 - 4.1.1. Select and identify two different vendors. Provide the listed price for (require labels for items)
 - 4.1.1.1. Identify the make and model of three long term storage options with the prices from both vendors.
 - 4.1.1.2. Identify the size/capacity of each option.
 - 4.1.2. The cost of each item is in monetary units in a spreadsheet. A formula must show a subtotal and grand total with tax added.
 - 4.1.3. Add to each subtotal column the ability to calculate the tax. The formula and the tax rate must be changeable.
 - 4.1.4. Explain which option you would add to your system.
 - 4.1.5. Identify if an AI type program was used to complete this lab section. If an AI program is used, identify the AI system used.
